Rules:

- All students must display their permit by hanging it on the rearview mirror of their car.
- The speed limit on school grounds is 5 mph.
- If a parking permit is lost or stolen report it to the main office immediately. Replacement cost is \$5.00.
- Permits are issued to a specific student. Students are not allowed to share, buy or resell permits.
- All school rules apply to your car while it is in on school property.
- If you need to access your car during the school day you must sign out and back in at the Main Office.
- Students must park in assigned areas. Parking in an unauthorized area may result in loss of driving privileges, other disciplinary action, or your car may be towed.
- An administrator may search cars if there is sufficient cause. The student will be notified and accompany the administrator to the car for the search.
- Driving through the staff parking lot and the visitor parking lot is prohibited.

A permit may be revoked (fee is nonrefundable) and additional disciplinary action may occur for the following:

- Violation of the Code of Conduct that involves a motor vehicle.
- Speeding or reckless operation of a motor vehicle on school property.
- Falsifying permit application.
- Sharing of a permit.
- Student being in a car or the parking lot during the school day without permission from the Main Office.
