Section 2: The announced reduction in force of non-teaching employment contracts will result in the elimination of scheduled mid-day work hours for the following individuals and placement on a recall list;

Section 3: The Superintendent and Treasurer are authorized to take those steps necessary to implement the announced reduction in force;

Section 4: It is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action were adopted in meetings open to the public, in compliance with all legal requirements including ORC 121.2.
